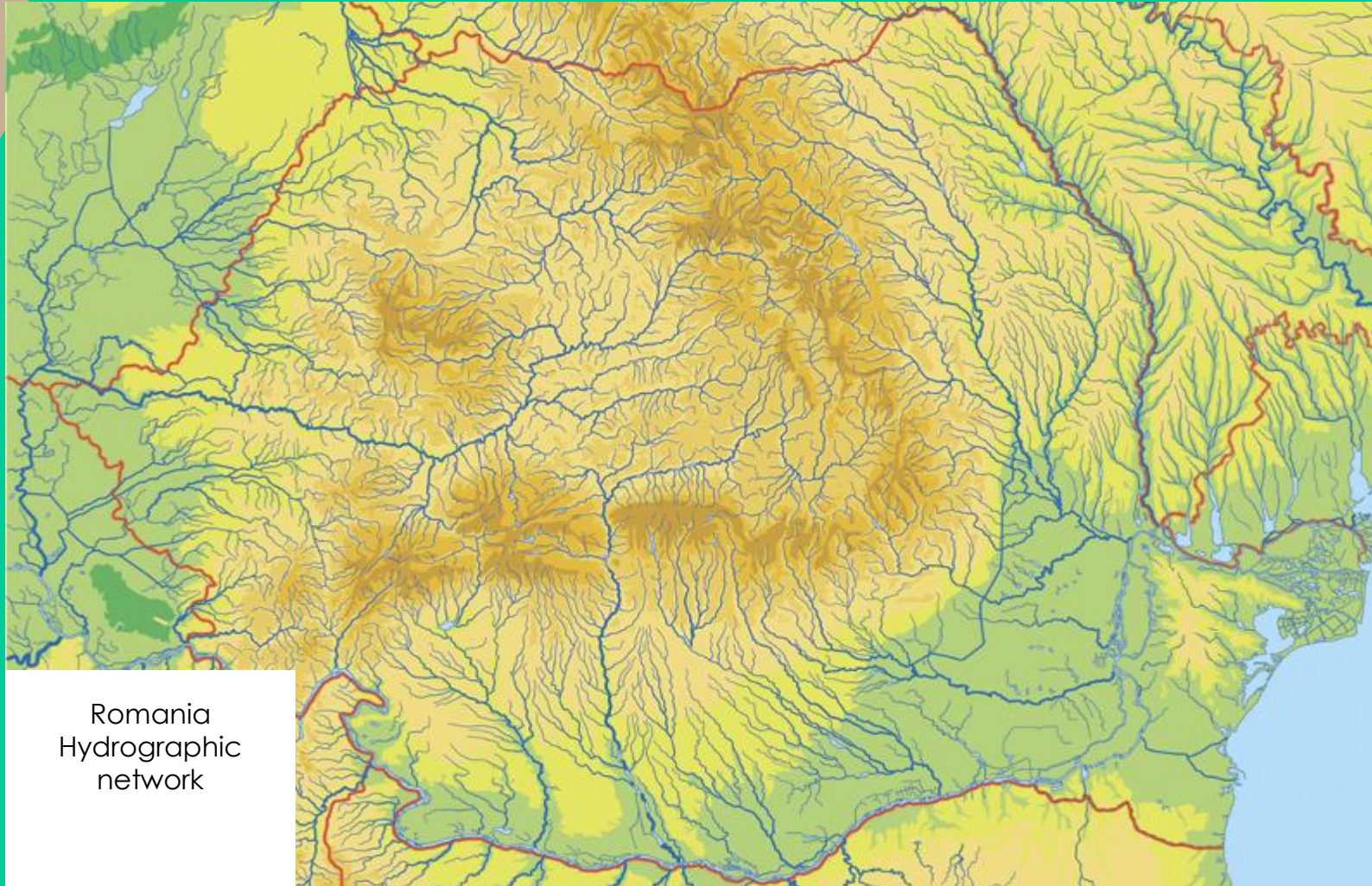

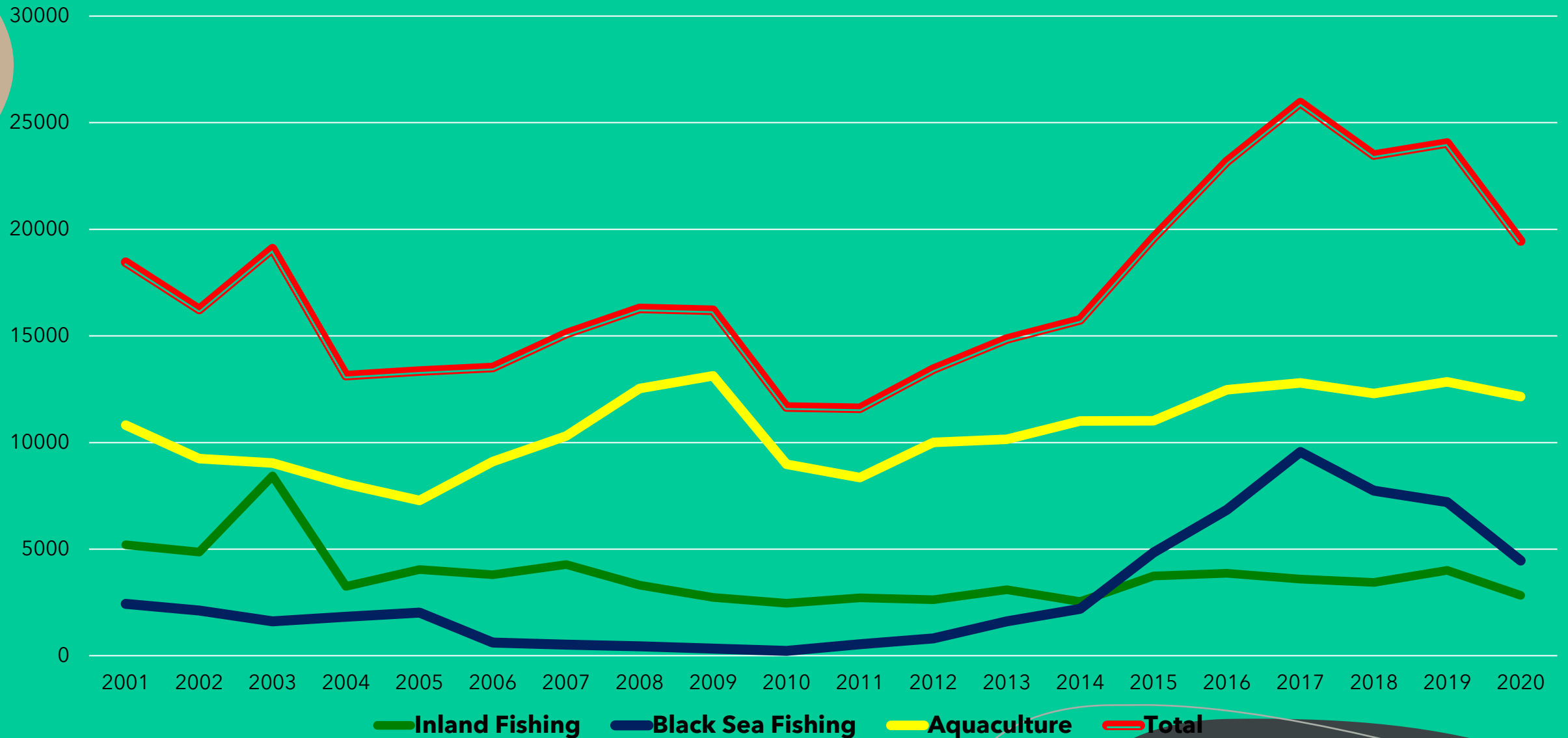

Evolution of the Romanian fisheries

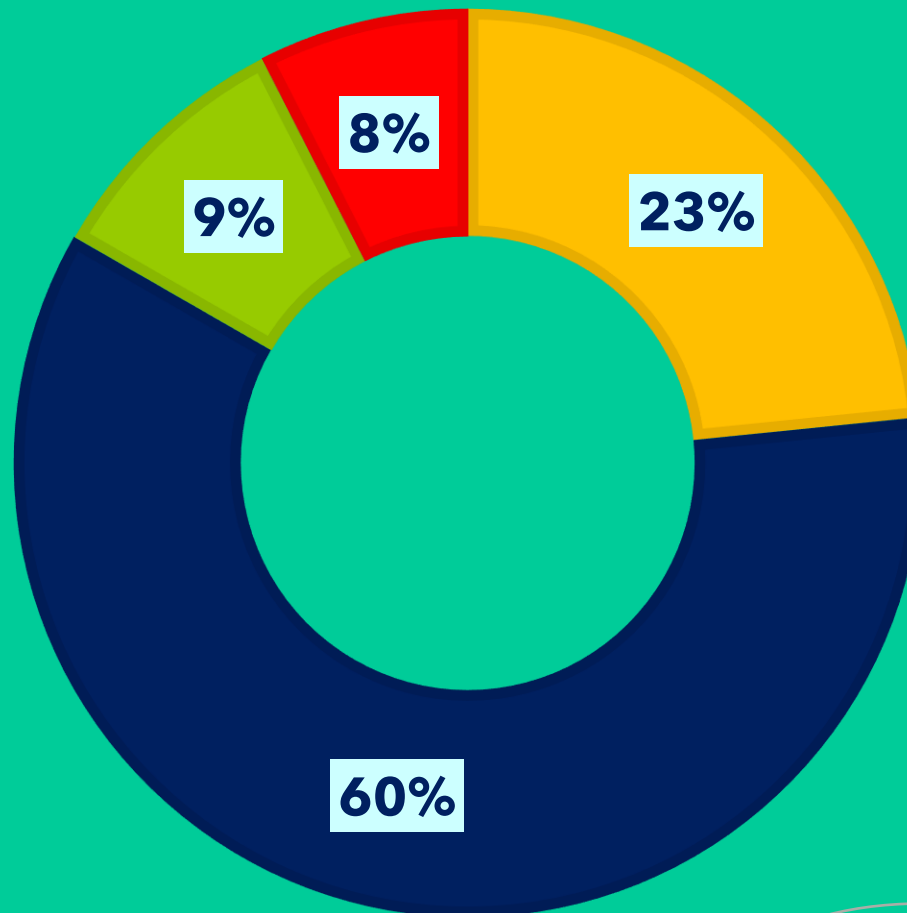

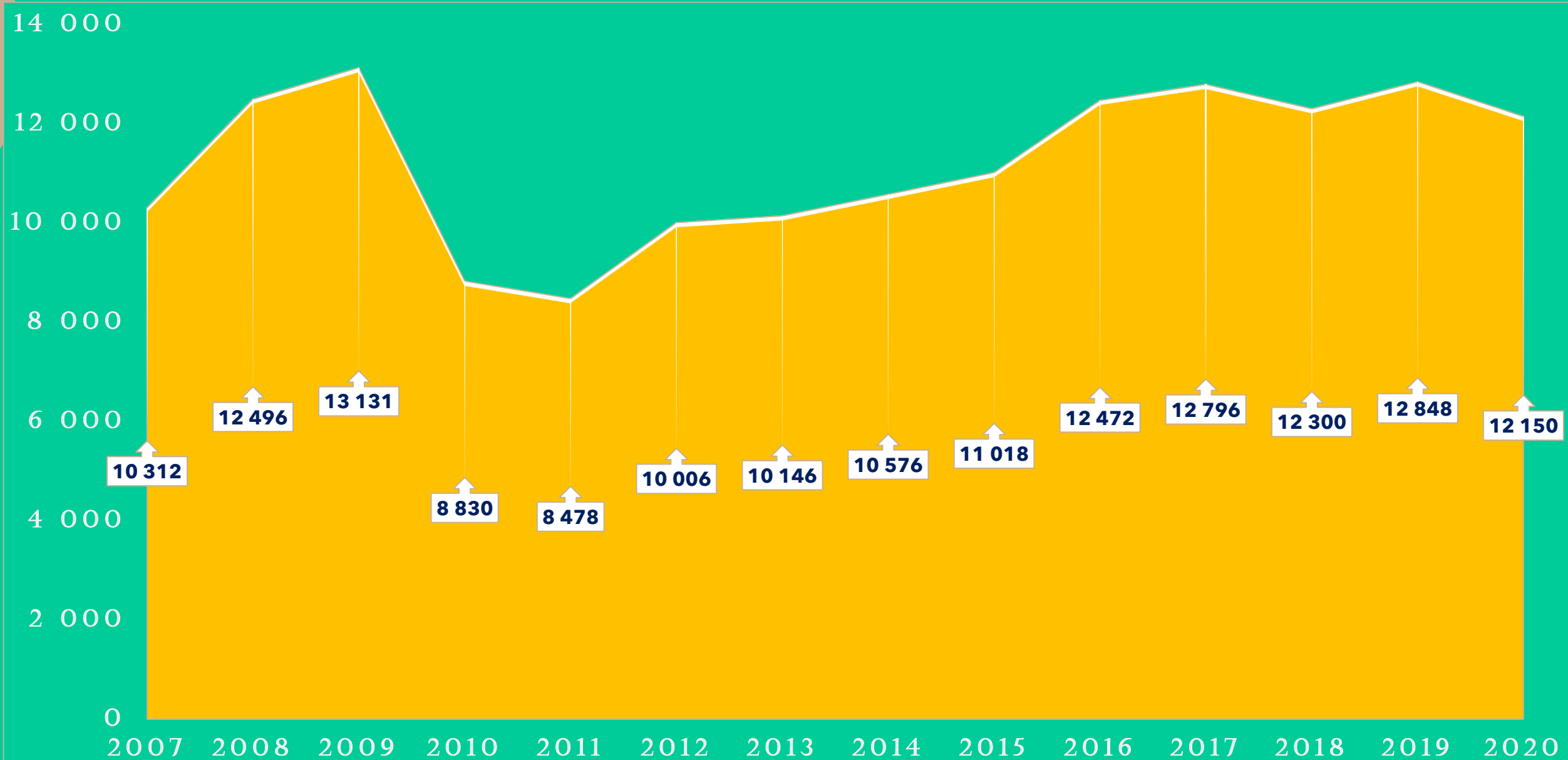


Sales channels of the locally farmed fish

Aquaculture sales, kg

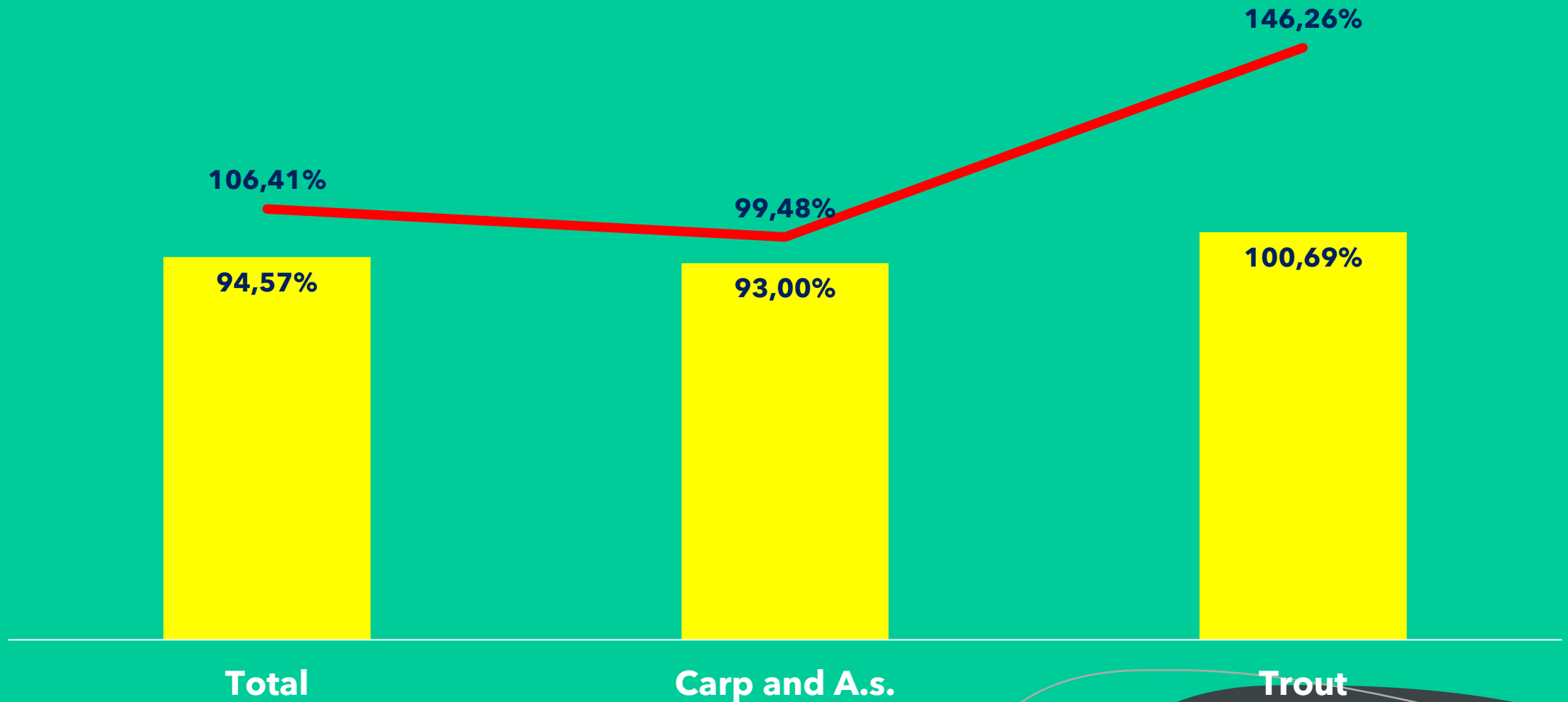


Structure of aquaculture sector

2020 vs 2019, sales volume - kg

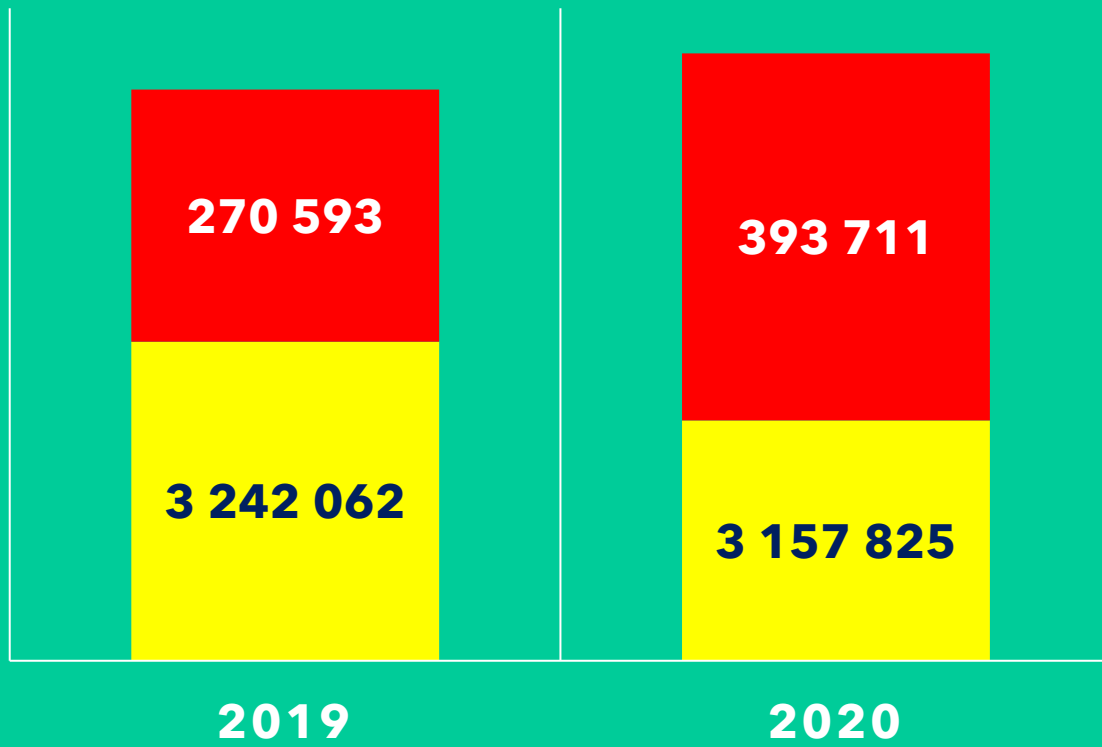

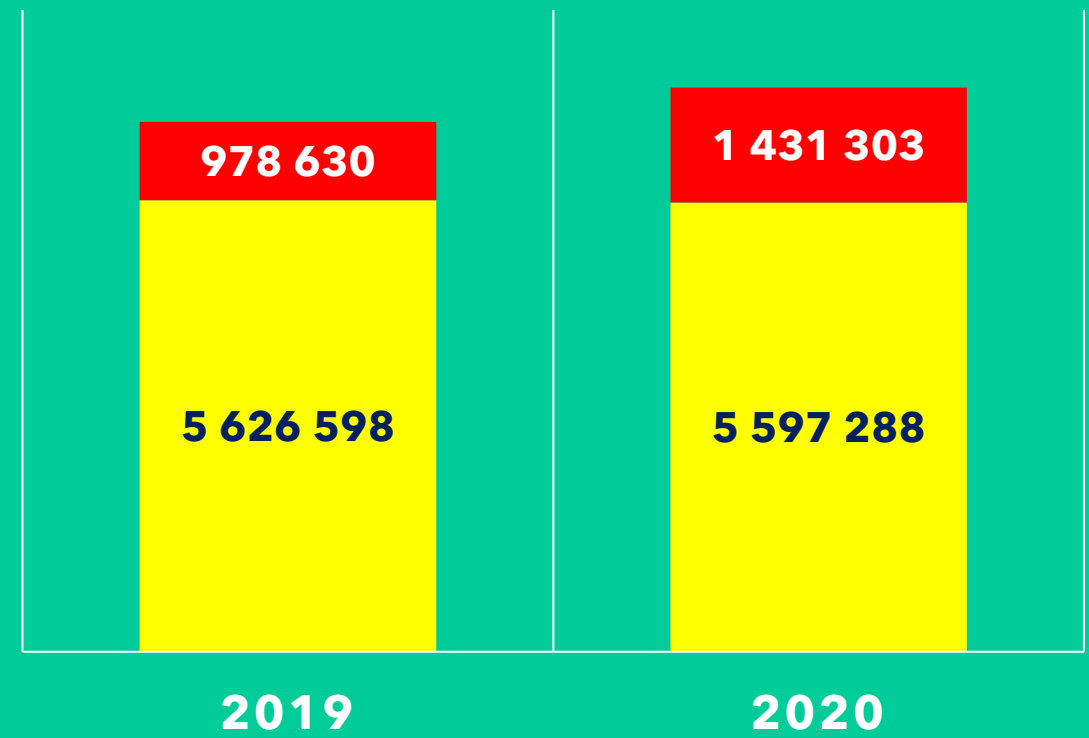

■ Cyprinids+As ■ Trout



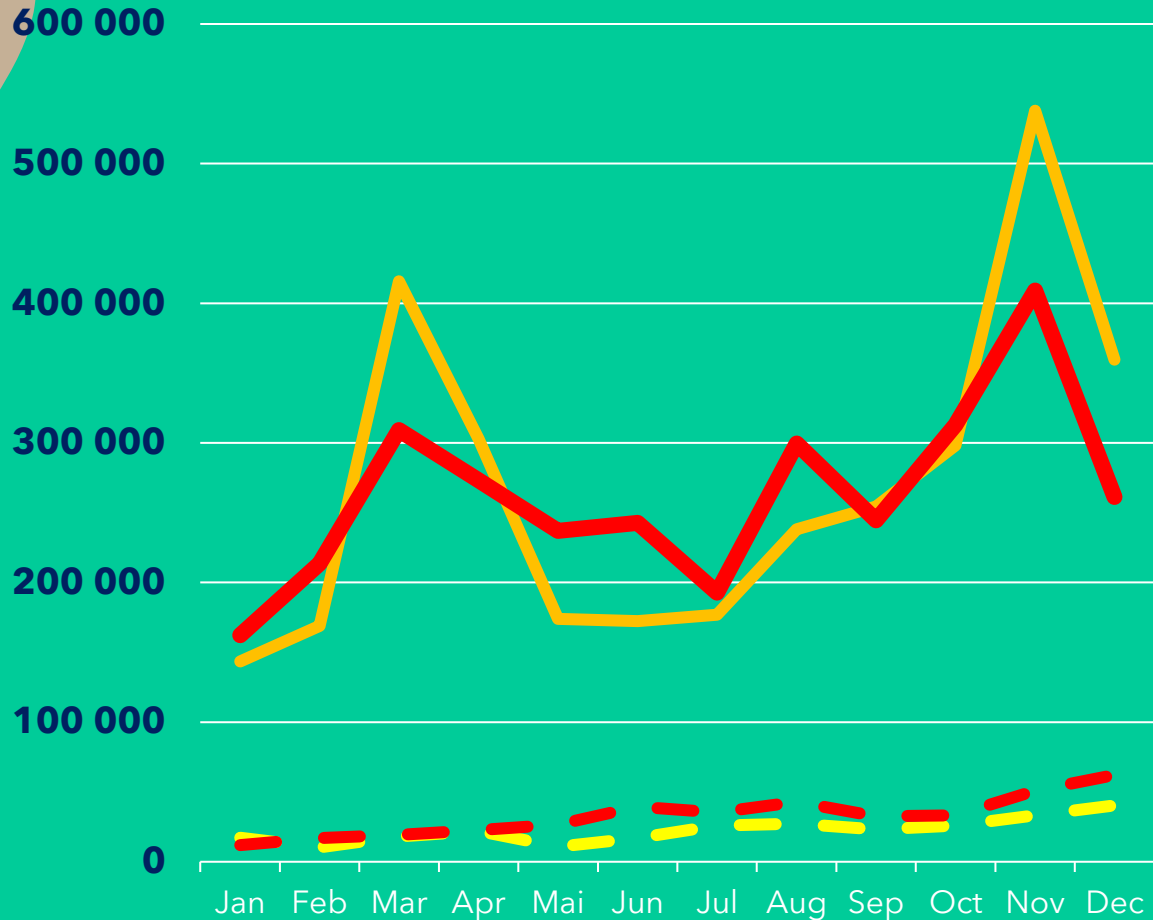
TURNOVER, EUR

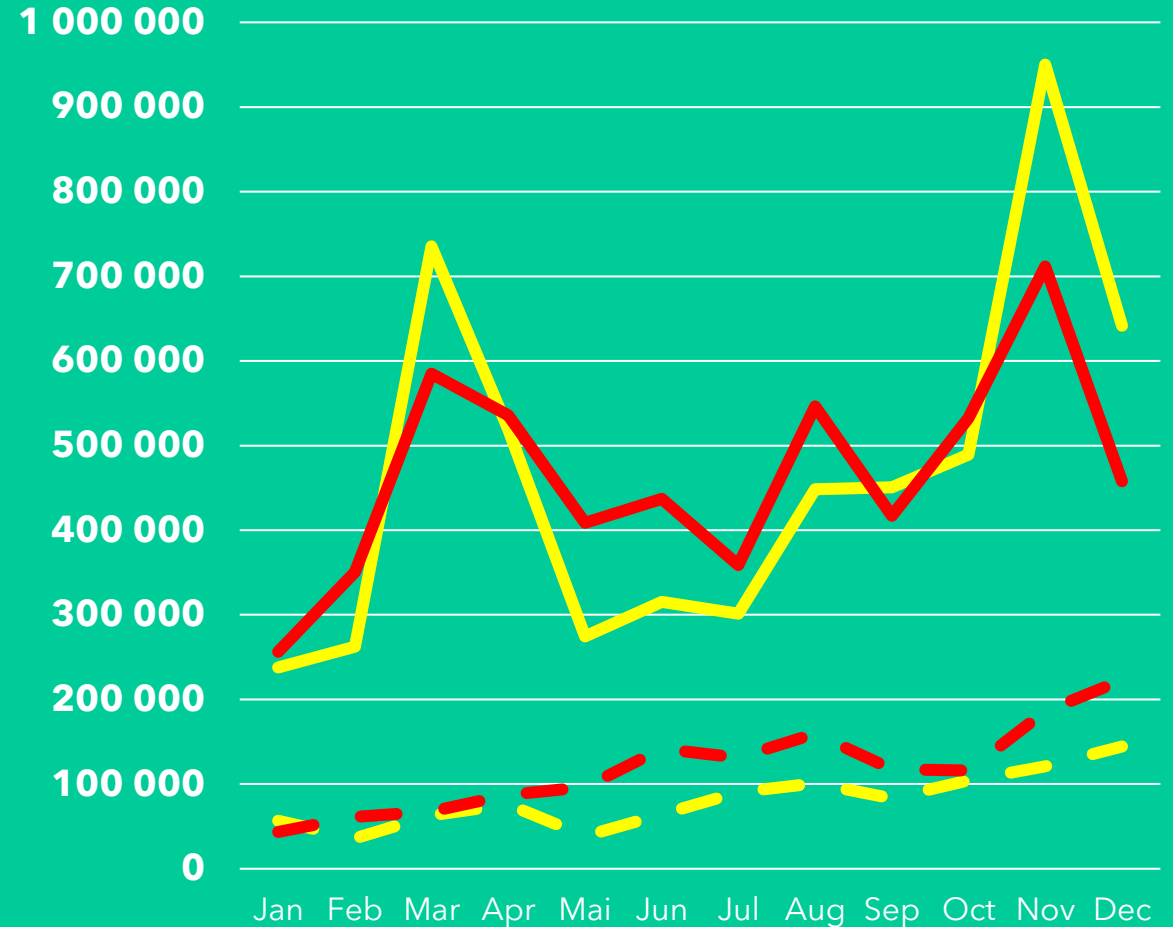


Sales volume contribution

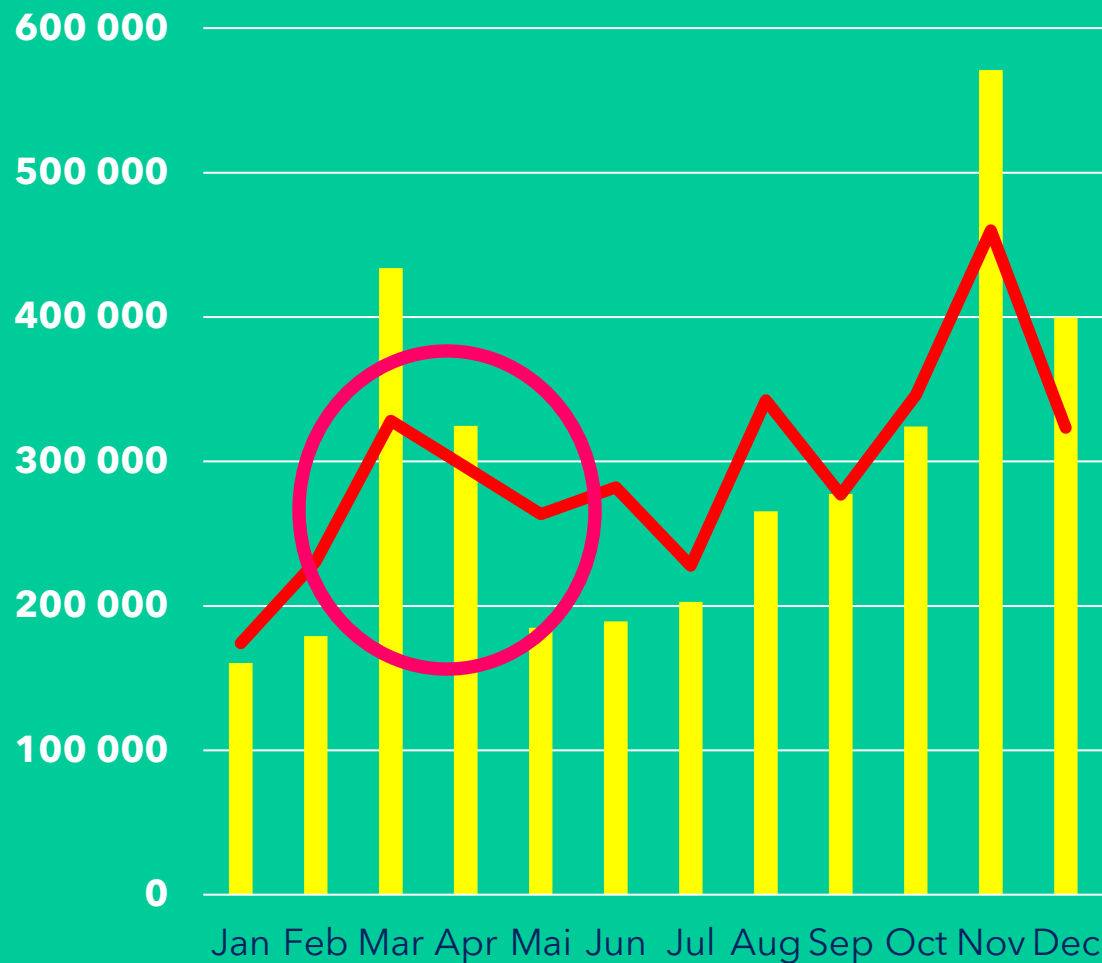

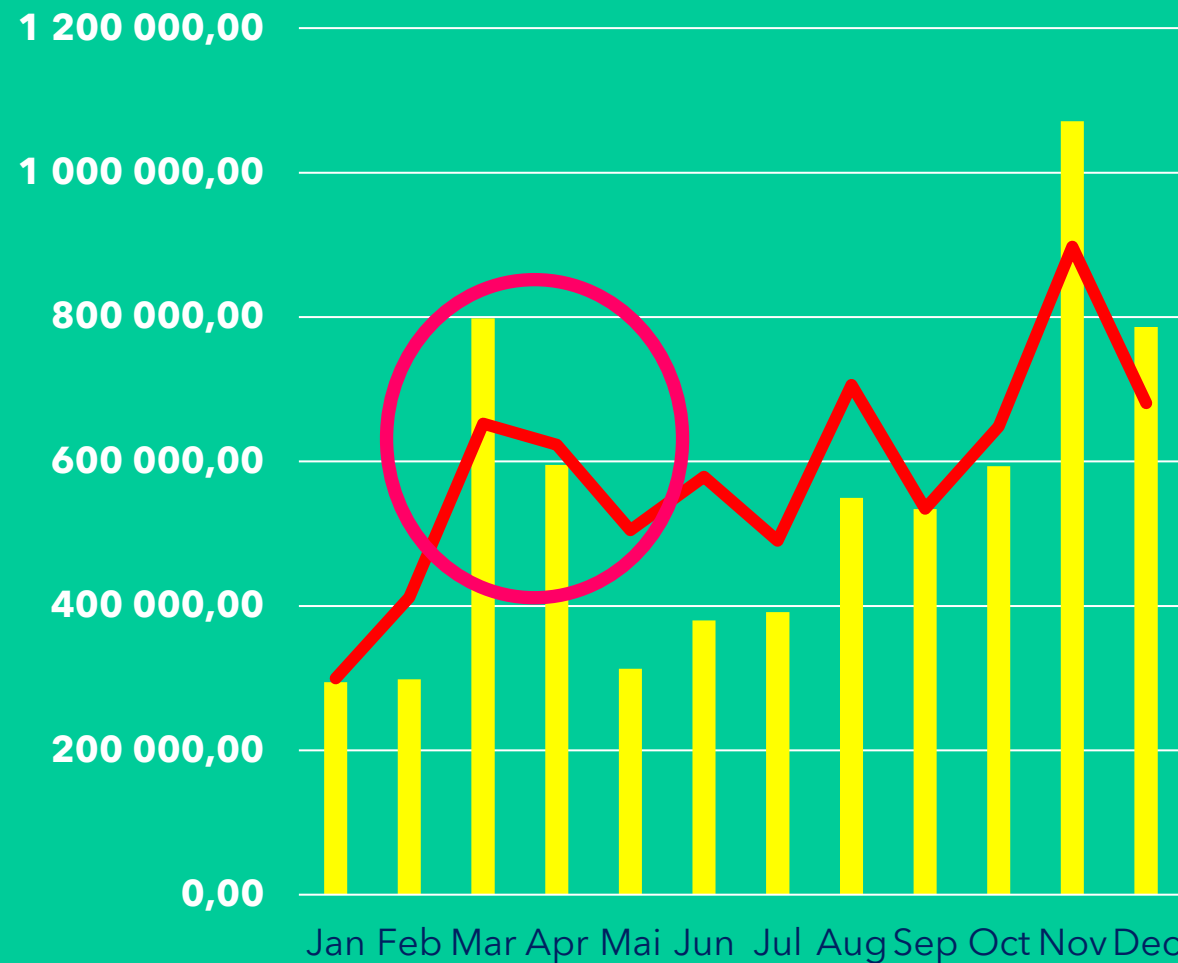

Problems identified

- **Live fish storage is not considered as in commercial fishing;**
- **Workforce is permanently challenged by other A or non-A businesses;**
- **Low capitalization due to unfinished privatisation;**
- **Overwhelming bureaucracy;**
- **Aquaculture does not benefit the same financial instruments as agriculture.**

Measures adopted

EU/National initiatives

- **Regulation 508/2013**
 - **Art. 55 - Public health measures**
 - **Art. 67 – Storage aid**
- **SME invest/Agro-Invest for working capital and investments as guarantee funds**
- **State Aid Temporary Framework– ceiling raised to 120.000EUR and 270.000EUR as guarantee funds and 10% grants;**

Analyses

- **Aquaculture Advisory Council - impact of the COVID-19 crisis on the EU aquaculture sector (deadline September 2021)**
- **FAO - The impact of COVID-19 on fisheries and aquaculture food systems, possible responses (Information paper, November 2020)**
