In this respect, I believe that the SEArICA Intergroup could remain a paramount tool to reflect on the implementation of the EU Green Deal, while calling for a Blue one.

Throughout these four years, the mission of the SEArICA Intergroup has been one of collaboration and commitment. I would like to express my warmest thanks to all SEArICA Vice-Chairs, to all SEArICA Members, for their active and valuable contribution in making SEArICA a major platform for political dialogue and policy assessment. I also particularly thank the [Conference of Peripheral Maritime Regions \(CPMR\)](#), which stands as the SEArICA Secretariat, for their great support.

Since 2009, the SEArICA Intergroup has sailed throughout EU mandates with the profound ambition to draw the attention of EU co-legislators on the main needs and potential of EU seas and rivers, as well as to raise the voice of citizens of islands, and coastal areas at EU level. 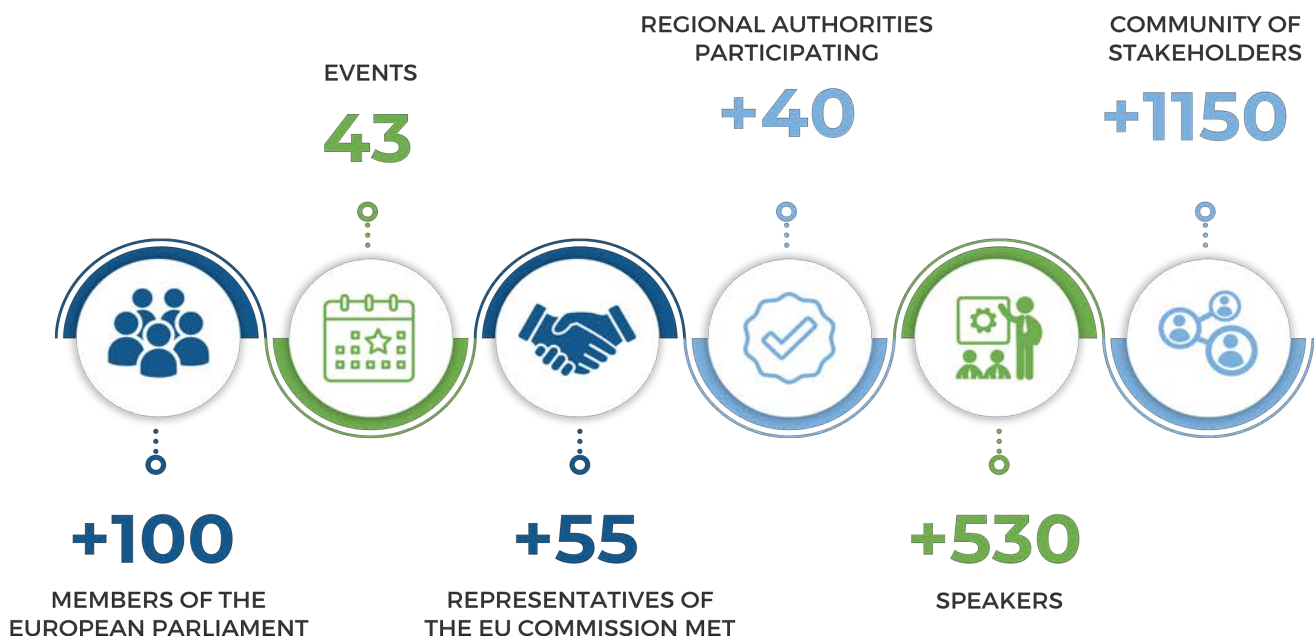




THE MISSION OF SEARICA

A VOICE FOR THE EU BASINS AT THE

EUROPEAN PARLIAMENT

With a steadfast commitment to translate the knowhow and priorities of coastal communities into EU policies, the SEARICA Intergroup has been a pivotal platform to elevate the voice of European citizens onto the EU stage. Bringing together key representatives from regional authorities, experts, universities, representatives of maritime private sectors and of EU institutions, the Intergroup has facilitated the formulation of propositions for actions and support at EU level. Through this sea-basin approach, the Intergroup has not only enabled a focus per sea-basin, but also exchanges of experiences, practices and lessons learnt between different areas.

STRIVING FOR A BETTER CONSIDERATION OF EU ISLANDS' UNIQUENESS AND NEEDS FOR ADEQUATE SUPPORT

With the hit of COVID-19 crisis and the need for EU recovery measures, the SEARICA Intergroup organised a roundtable hosted by **MEP Younous Omarjee** to reflect on the future of regional State Aid. Proposals for the revision of the rules to maximise these investments in consideration of islands and maritime regions' specificities have been debated. A year later, in preparation of MEP Younous Omarjee's [INI Report](#), the SEARICA Intergroup held a special conference on Islands & Cohesion Policy hosted by **MEP François Alfonsi**, shadow rapporteur on the file. This event allowed to contribute to the political debate by continuing the discussion on state aid schemes, address islands' challenges on biodiversity climate change, focus on islands' characteristics generating additional costs, and discuss the creation of an Islands Pact, with a view to define a common EU policy on islands issues. The INI Report "EU Islands and Cohesion Policy: Future current situation and future challenges" was adopted in June 2022.

As the European Commission released its new Circular Economy Action Plan, the SEARICA Intergroup also addressed the case of coastal and islands region for its implementation. Hosted by **MEP Josianne Cutajar**, regional representatives, the European Commission, and representatives from EU projects have reflected on actions to put in place to help islands in the implementation of the Plan and benchmarked existing practices across maritime and islands regions.

SUPPORTING INNOVATION AND REGIONAL COOPERATION FRAMEWORKS IN THE DANUBE & BLACK SEA

With the active support of **MEP Carmen Avram**, the SEArca Intergroup has been a consistent EU forum driving maritime regional cooperation and supporting regional frameworks such as the Common Maritime Agenda (CMA), the EUSAIR macro-regional strategy, and the Strategic Research and Innovation Agenda (SRIA). Along these four years, the Intergroup has regularly organised political events to address challenges and seize opportunities for full implementation and engagement of these cooperations, with focus on the Blue and Innovative dimension of their priorities. With the perspective of safeguarding the Danube & Black Sea unique environment and build a more sustainable future, events have also been organised on the marine litter-related challenges, as well as on the future of fisheries and aquaculture in the area, enabling cross-sea basin exchange of knowledge and experiences to nurture future actions.

In May 2023, the [Final SRIA Implementation Plan](#) has been launched during a SEArca event hosted by **MEP Marian-Jean Marinescu**. This guide aims to support the preservation of the Black Sea's distinctive habitats, foster sea-based sector growth, and stimulate employment through collaborative efforts across academia, funding bodies, industry, policy makers, and civil society.

HARNESSING THE STRATEGIC ROLE OF THE BALTIC AND THE ARCTIC

In light of a new geopolitical context and the accelerating climate and energy independence challenges, SEArca has actively reflected on the role of the Baltic Sea as frontrunner for a green transition and European energy sovereignty and security under the impulse of **MEP Nils Torvalds**, also addressing focused discussions such as on the role of ports in the implementation of the EU Green Deal.

Mirroring the European Commission's launch of its [Communication](#) for a green, peaceful, and prosperous Arctic, the SEArca Intergroup decided to increase its action on the issue with the appointment of a new Vice-Chair for the Arctic, late **MEP Erik Bergkvist**. In 2022, MEP Erik Bergkvist kicked-off the activities by hosting a political discussion on the potential and challenges for the green transition and blue economy in the Arctic, and on means to increase interregional cooperation to maintain a peaceful Arctic. In this respect, the SEArca Intergroup allowed to enlarge the reflection on the future of the area beyond the sectoral approach, with specific attention to Arctic coastal communities' needs and priorities.

TAPPING IN THE FULL POTENTIAL OF THE ATLANTIC

With the release of the Atlantic Action Plan 2.0 of the EU Atlantic sea-basin strategy (AAP 2.0), the SEArca Intergroup has followed the implementation of the new priorities agreed by the four EU Atlantic Member States. In a dedicated event to the Plan, the SEArca Intergroup invited sectorial representatives to share their perspectives on the new priorities, but also brought together the expertise of various intergovernmental strategies to reflect on the lessons learnt and potential needs to optimise the Atlantic Strategy's governance. Mirroring the priorities of the sea-basin strategy, the Intergroup has hosted discussions on the AAP 2.0 advancement and discussed political recommendations as for [ASPBAN](#), the pilot project of AAP 2.0 Pillar I “Ports as Gateways and Hubs of the Blue Economy”, hosted by **MEP Deirdre Clune**. SEArca Members have also reflected together on how to bridge scientific research and political initiatives to address Marine Litter in the Atlantic, contributing to the AAP 2.0 Pillar IV “Healthy Oceans and Resilient Coasts”.

Inspired by the SEArca exchanges on marine litter, **MEP Catherine Chabaud** called for the continuation of the [CleanAtlantic project](#) in her [INI Report](#) “Impact on Fisheries Marine Litter”, adopted in March 2021. Today, the partnership has successfully renewed their collaboration through the approval of the [FreeLitterAt project](#) that will address the prevention and reduction of macro and micro litter in the Atlantic until 2026.

REFLECTING ON ENHANCING THE SUSTAINABILITY AND RESILIENCE OF THE MEDITERRANEAN

Throughout this term, the SEArca Intergroup has particularly addressed the EU action to enhance the sustainability of the Mediterranean economies. With a specific focus on the tourism sector, SEArca has been a political bridge to address this key economic transition for the area with policymakers. With regional representatives across the Mediterranean, SEArca members have discussed key recommendations arising from the [INI Report](#) “EU Strategy for Sustainable Tourism” of **MEP Claudia Monteiro de Aguiar**, SEArca Vice-Chair for Outermost Regions. The SEArca Intergroup has also particularly addressed climate resilience, biodiversity protection and restoration challenges across several events of this term, with important representation of the specific challenges of the Mediterranean and policy recommendations from EU projects.

Throughout this term, the European Green Deal has highlighted the critical importance of the seas, rivers, islands, and coastal areas in achieving Europe's objectives. With the release of pivotal new legislation, the SEArca Intergroup has played a key role in monitoring the maritime dimension across EU policies, strategies and programmes. By actively engaging in discussions strategically aligned with the EU legislative process, the Intergroup has strived for EU policies to offer the necessary framework, support, and conditions to fully harness the potential of maritime and coastal areas in its implementation.

THE EU MISSION OCEANS & OCEAN OBSERVATION

While SEArca had been on the forefront to fight for the creation on Mission for Oceans in the research and innovation programme Horizon Europe during its 2014-2019 term, it is with great excitement that the renewed Intergroup 2019-2024 took up the torch and kicked off its activities with a dedicated event. On that occasion, SEArca members, the scientific community, DG RTD, and representatives of the civil society discussed and advised on the launch, context, and next steps of implementation of what became the [EU Mission: Restore our Ocean and Waters](#).

A year later, SEArca concluded the European Commission's public consultation on Ocean Observation with a related discussion hosted by **MEP Alicia Homs** and with the participation of **MEP Catherine Chabaud** and **MEP Ville Niinistö**, in collaboration with DG MARE.

THE FIT-FOR-55 PACKAGE

With the release of the fit-for-55 package, which included proposals directed to waterborne transport and aviation such as FuelEU and the Alternative Fuels Infrastructure Directive (AFIR), SEArICA hosted a comprehensive discussion when the negotiations on the different files reached the European Parliament. Together with representatives of DG MOVE, maritime sectors, coastal regions, ports and NGOs, **MEP Tonino Picula**, **MEP Petros Kokkalis**, **MEP Rasmus Andresen** (ITRE FuelEU Rapporteur) and **MEP Caroline Nagtegaal** (TRAN shadow rapporteur for AFIR) have addressed the path to decarbonisation of maritime transports through the EU legislative context. A follow-up session, addressing FuelEU, the Social Climate Fund and ReFuelEU Aviation has been organised in the next months also in the presence of **MEP Claudia Monteiro de Aguiar**, **MEP Jan-Christoph Oetjen** and **MEP Catherine Chabaud**, as well as thematical events to explore measures to help the shipping industry to reduce its emissions.

THE REVIEW OF THE REGULATION ON TRANS-EUROPEAN TRANSPORT NETWORK (TEN-T)

Considering the European Commission's proposal to review the TEN-T regulation that established both the funding priorities and EU transport infrastructure standards for the years to come, the SEArICA Intergroup hosted a discussion on its maritime dimension. With the participation of DG MOVE, regional and maritime transports representatives, **MEP Jan Christoph Oetjen**, **MEP Tonino Picula**, **MEP Isabel Garcia Munoz** (TRAN Shadow-Rapporteur on the TEN-T), assessed whether the European Commission's proposal answered the calls from the European Parliament and the maritime sector, considering mirroring Initiatives Reports dedicated to the TEN-T and maritime transport.

THE EUROPEAN COMMISSION'S COMMUNICATION ON A NEW APPROACH TOWARDS SUSTAINABLE BLUE ECONOMY

As a conclusion event for the feedback process on the European Commission's roadmap for its communication on sustainable Blue Economy, **MEP Petros Kokkalis** hosted a SEArice Blue Economy conference in cooperation with DG MARE. Together with regional, national, sectoral blue economy sectors, **Commissioner Virginijus Sinkevicius** and SEArice Members engaged on the content of the future communication that would guide the vision of the European Commission towards sustainable blue economy for the years to come.

As a complementary exercise, SEArice has also hosted a Conference on Blue Skills, to reflect on the maritime dimension of the launch of the EC Pacts for Skills and future initiatives and proposals to support the next generation of maritime professionals, and a conference on Blue SMEs.

THE NATURE RESTORATION LAW PROPOSAL

Ahead of the vote in plenary, **MEP Pierre Karleskind**, **MEP Catherine Chabaud**, **MEP Caroline Roose** and Rapporteur **MEP Cesar Luena** came together on the marine dimension of the proposal on nature restoration. Together with scientific experts, civil society and fisheries producers' representatives, they addressed core elements of the text and discussed the main needs to ensure effective implementation, such as data collection and harmonisation with other EU directives.

THE EU CLIMATE LAW AND EU ADAPTATION STRATEGY

In light of the EU Climate Law and the EU Adaptation Strategy, SEArICA has especially reflected on the special needs of maritime and coastal areas, as being in the forefront of climate change consequences such as sea-level rise, coastal erosion, floods and extreme temperatures. Throughout a series of events, notably hosted by **MEP Josianne Cutajar** and **MEP Catherine Chabaud**, SEArICA Members have exchanged on the experience and practices of regions and islands from different sea basins and has set discussions on the EU action and support to coastal areas together with DG CLIMA, European Investment Bank, European Environmental Agency and experts to ensure effective adaptation and resilience of these areas.

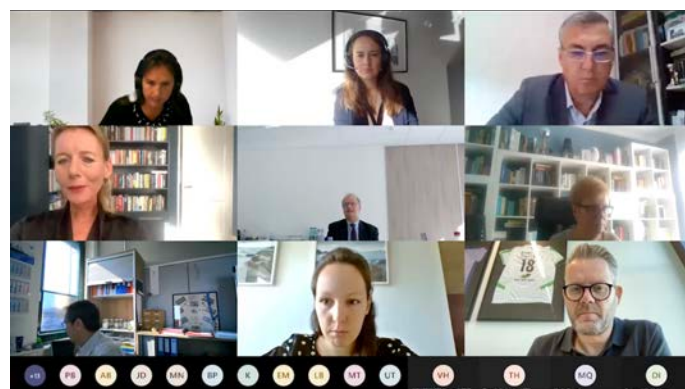
SEARICA IN SUPPORT TO THE MARITIME SECTORS' RECOVERY

With this term being historically marked by COVID-19 crisis that deeply affected maritime economic activities, and therefore the prosperity of coastal communities, the SEArICA Intergroup has been a vocal ally to support the EU action in their recovery. In the urgency to act, the SEArICA Board has met with Commissioner Sinkevicius in May 2020, to stress the need for urgent and specific measures considering the revised MFF and EU Recovery Plan, sharing their key proposals with the support of a [signed declaration](#). The Intergroup has hosted several high-level discussions for maritime industries' recovery, and focused ones on the tourism sector, while streamlining the reflection on their recovery and transition along the whole mandate.

In addition to supporting the legislative process at the European Parliament, the SEArica Intergroup has also represented a place for exploration of new themes and challenges and a high-visibility platform for SEArica Members to nurture their own initiatives and address other issues of their interest. Under the impetus of its Members, the SEArica Intergroup has become a laboratory of new ideas at the European Parliament to shape and voice innovative ideas for the future of coastal and maritime areas.



On the proposal of **MEP Jan-Christoph Oetjen**, SEArica Members reflected on the future of water-based tourism. Together, SEArica Members signed a [common declaration](#) with five proposals to develop common rules to boost a EU sustainable nautical tourism.



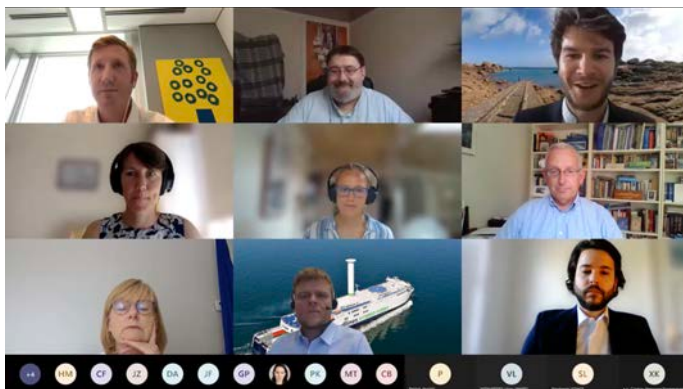
As part of her own-initiative report “Towards Future-Proof Inland Waterway Transport in Europe”, **MEP Caroline Nagtegaal** hosted a discussion to identify the barriers to overcome and the way to move forward for IWT sector in light of the EU Green Deal, with sectorial experts and representatives from the EU Commission.

Together with **MEP Carmen Avram**, she also hosted a dedicated discussion on the Danube River building on NAIADES III programme.



With the support of **MEP Catherine Chabaud** and **MEP Cyrus Engerer**, the Ocean Framework, a tool developed by Fondation de la Mer for and with companies to identify and measures their impact on the Ocean and set objectives for improvement, has been presented at the European Parliament. SEARICA Members have discussed its contribution and connections with EU policy and initiatives, such as the EU Mission Ocean.

Recalling the European Parliament's calls for an international moratorium on deep-sea mining, **MEP Caroline Roose** and **MEP Marie Toussaint** have brought together ministerial representatives, the EU Commission, scientific and civil society experts to discuss pathways for future EU initiatives to safeguard the deep ocean from mining harm.



Willing to explore the potential of wind propulsion to contribute to the Green Deal, **MEP Jan-Christoph Oetjen** hosted a discussion with experts, representatives of the EU Commission and **MEP Catherine Chabaud**, **MEP Deirdre Clune** and **MEP Petros Kokkalis** to dive into how the shipping industry could deliver on decarbonisation, to reduce carbon and other GHG emissions by using a set of technologies and approaches already available today.

Together with experts and policy makers, **MEP Tonino Picula**, **MEP Jan-Christophe Oetjen**, and **MEP Pierre Karleskind** addressed challenges of underwater noise, in light of the award-winning documentary "Sonic Sea".
